ORDER

WHEREAS, K.S.R Educational Society, Kadapa District, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to **Prasad College of Education, D.No. 11/322, D.C. AND WHEREAS, the Provisional revised order issued to the institution on **06.05.2015**.

AND WHEREAS, on 10.07.2015 a letter is received by this office from the Correspondent, KSR Educational Society, Kadapa District, Andhra Pradesh regarding requesting for shifting premises.

AND WHEREAS, in the meantime the institution had submitted applications for M.Ed (SRCAPP14513), D.El.Ed-AI (SRCAPP14512) & APS07034/B.Ed courses for the year 2016-17. The SRC in its 294th meeting held during 14th to 16th November, 2015 considered the matter and decided as Cause composite inspection of the institution for all the courses.

AND WHEREAS, as per the decision of SRC a composite inspection was conducted for SRCAPP14513/M.Ed SRCAPP14512/ D.El.Ed-AI and APS07034/B.Ed on 21.02.2016 and the Visiting team report is received by this office on 28.01.2016.

AND WHEREAS, on 28.04.2016 a letter is received by this office from the principal, Prasad college of Education, kadapa District, as under :-

"As per the reference cited above, I hereby request you to kindly issue shifting premises recognition order for B.Ed course inspected by the NCTE Visiting Team Committee on 22.01.2016.

AND WHEREAS, the Southern Regional Committee in its 312th meeting held during 28th to 29th April, 2016, considered the matter and decided as under:-


